# Highlights from the previous Meetings

- The Board of Directors (BOD) is working with Brooks Real Estate (BRE) to schedule a community inspection. There have been some changes in personnel in BRE and has led to delays. The inspection is scheduled for late March. A notice will go out to LHS before this happens.
- Clearwater Pools was selected as the new pool company and was chosen to complete needed pool updates. There are new swim regulations that homeowners will need to abide by, for the 2025 pool season. Please note that CP only allows USCG approved flotation devices for non-swimmers. More guidelines will be posted in the pool documents when receiving a pool pass.
- LHS has submitted the application for BMP grants through JCC for \$17,000. Four bids were obtained for a new BMP management company. JCC will also be involved to determine the scope of work and if the contracts align with JCC BMP regulations.
- The LHS dues for 2025 have been raised from \$70/month to \$74/month. There has been a noted "glitch" in the BRE accounting string. All homeowners are encouraged to reference the email sent by Melissa for re-establishing your HOA account, to prevent service fees from Appfolio. Also, any incurred late fees that were part of the "glitch' are going to be reversed or credited by BRE.
- The BOD received a quote for the trimming of the crepe myrtle trees at the front entrance.
   The trees are overgrown and blocking necessary

- lighting. The BOD voted to get the trimming completed.
- Melissa Sabb is still the interim PM for LHS. BRE hasn't assigned a permanent replacement, yet.
- The BOD has voted for Melissa to handle all delinquent dues, that are 90 plus days overdue.
   If a homeowner has problems paying their dues, they should contact Melissa to establish a plan.

This application can be found on our WebSite, Appfolio, or call BRE for a copy. Please see the by-laws for a complete list of projects that require ARC approval. The ARC Guidelines were developed to protect the integrity of our neighborhood and our property values.

The **Grounds Committee** is led by Adam Zuchara. Many thanks to him for completing special projects around the neighborhood. However, this committee could use extra help, too. If you are interested in helping our community, please reach out to him!

The **Pool Committee** is led by Sonja Winnington. Special thanks to her for leading many events throughout the summer season! This committee is also in need of volunteers.
